# Should ISA adopt these changes?

Three areas are being affected by these changes—age categories, size of balls, and pitching distances.

For example, with the change in age categories, 10-year-old children will be in U11 with no ball size change and a pitching increase of 5 feet (30 feet to 35 feet). See the charts below:

In emails submitted, Dundalk, Kincardine, Listowel, Port Elgin, Tara and Walkerton support changing to the Softball Ontario rules.

For those present at the meeting, the consensus is that 10-year-olds already have difficulty pitching 30 feet. The move to 35 feet is not productive to developing skills. Also, children have lost basic skills during the two seasons affected by this pandemic; it does not seem appropriate to make changes at this time.

We should not follow Softball Ontario blindly but think about what is best for our children.

If age category changes are accepted, ball and hockey ages are inconsistent.

The safety issue of using loaded bats and red dot or green dot balls came up during these discussions. Should ISA ban their use through amendments to our rules? (Example: only allow gold dot balls.)

### \*\*\*\*VERY IMPORTANT\*\*\*\*

If your centre wants to make proposed changes to the ISA Constitution and Rules, they must be introduced, accepted, or declined at the February 2022 AGM.

There are deadlines that must be met to introduce recommendations at the 2022 AGM:

- October 31st, 2021 centre recommendations must be submitted in writing to Steve Warmington
- December 1<sup>st</sup>, 2021 Steve Warmington will forward submitted recommendations to all centres for consideration

Recommended changes will be voted on at the 2022 AGM. Attendance is important since each centre gets a maximum of two votes.
