

# Meeting

September 17, 2023/1:30 p.m. | Meeting called to order by Steve Warmington

## Welcome

Welcome, from Steve Warmington to the ISA yearend meeting. Thanks to all of you for contributing your time so our children can play ball.

It was an interesting year with several concerns arising from different coaches/convenors on the need for changes to the ISA Bylaws and Constitution. Here are some of the concerns:

- Clarification of "replanting" pitching rule
- Limiting the number of batters that can be hit by a pitcher before the pitcher is replaced in a game
- Procedure to follow when a coach or team refuses to follow ISA rules
- Substances allowed to be used by pitchers, for example rosin bags or spider's wax
- Strong hitters walked intentionally.

These concerns need to be discussed by the various centres and addressed via ByLaw or Constitution proposed changes. These recommended changes must be submitted in writing, with two different centres approving the proposal, to the president by November 1<sup>st</sup>, 2023.

The submitted proposals will be discussed at the February 2024 meeting and voted on by ISA members (2 votes per centre).

### Year End Report By Convenors & Convenors For 2024

Ruth Risidore is willing to run for ISA President at the February 2024 meeting. If she is voted in, there will be a need for a new ISA Vice-President.

Note that some duties performed currently by the ISA President could be delegated to others to make the task less time consuming. This can be discussed at the February meeting.
